TERMS AND CONDITIONS

Particularly since post September 11th, we need to be sensitive to security and safety that may affect international travel. We will take precautions to ensure the safety of our students, however, it must be understood that security and safety can be compromised due to political instability, extreme inclement weather, risks to health, and other circumstances. Accordingly, ILCEX, LLC reserves the right to cancel your trip at any point up to your date of departure. If circumstances arise during your trip that compromises the safety or security, your trip may be cut short.

In addition, ILCEX, LLC expects all participants to respect their fellow volunteers and the residents of the community in which you will be staying. ILCEX,LLC reserves the right to ask any participant to leave the community if the participant engages in acts of serious misconduct, including violations of ILCEX,LLC policies, violations of the law (of the host country or sending country), and acts that are determined by ILCEX,LLC to constitute serious misconduct.

If your trip is canceled or cut short, ILCEX, LLC shall not be responsible for reimbursing you for your nonrefundable expenses. If you are asked to leave the community due to an act of serious misconduct, you shall do so at your own expense.

1) A non-refundable \$100 reservation deposit must be received before a completed application will be considered for acceptance. The payments are due 50% before the purchase of the airline tickets and the rest 4 weeks prior to the departure date.

2) If I terminate the trip early for any reason, I will not be refunded and I will incur any necessary expenses for travel changes.

3) If ILCEX, LLC terminates my trip early for any reason, I will not be refunded and I will incur any necessary expenses for travel changes.

4) TRAVEL ARRANGEMENTS

Participants are generally expected to use the transportation provided by ILCEX, LLC between the ports of departure and return. Requests for alternative travel must be made in writing by the Participant and, if the Participant is under 18, by the Participant's parents or guardian, and must be approved by ILCEX, LLC in advance. Participants traveling independently before or after any scheduled Program should not expect the assistance of staff members of ILCEX, LLC.

No independent travel during the Program is permitted without the express consent of ILCEX, LLC and, if the Participant is under 18, the written consent of his or her parents or guardian. In signing this form, the Participant and parents agree not to arrange or encourage personal travel abroad for any purpose not related to the Program, nor to arrange or encourage visits to the Participant by family or friends, without the express written permission of ILCEX, LLC.

Travel expenses arising from premature return home from abroad, either alone or accompanied, must be borne by the Participant.

5) AIR TRANSPORTATION

ILCEX, LLC arranges scheduled air transportation through designated airlines or travel agents and has designated or will designate the times and ports of departure for all group transportation. ILCEX,LLC, the agents selected by it, and the airlines reserve the right to cancel the air transportation arrangement or change dates,



times, prices, and itinerary, and to make aircraft substitutions. In the event changes or substitutions are made by ILCEX, LLC, its agents, or the airlines at any time prior to the Program date, ILCEX, LLC will not be responsible for the cost of domestic airline tickets purchased on the basis of previously published international transportation information.

Each Participant is solely responsible for any missed connections due to his or her failure to assemble in a timely manner, and ILCEX, LLC will be in no way liable for the cost of alternate transportation or for any consequential losses resulting from the Participant's failure to use designated transportation.

6) IDENTIFICATION

All Participants must be prepared to present some form of numbered positive identification that matches the name on the passenger manifest when boarding the aircraft. A passport or travel identity document must be shown for international travel.

7) FAMILY PLACEMENTS

GUIDELINES AND REGULATIONS

Coordinators will be responsible for the safety of the students. Also they are responsible to ensure adequate behavior from students during the duration of the trip. Students shall follow the regulations and guidelines provided at all times.

Students need to be respectful with the infrastructures around them in school, at home and with the rest of the environment.

In Spain, tobacco as well as the use of alcohol under the age of 18 is forbidden. Not to mention the intake of any type of drugs. The transgression of these rules would mean an automatically expulsion from the program and return to the country of origin at the parents'/guardians' expenses.

Even though shoplifting sometimes could look like an easy thing to do, it is much punished, just like it would be in the USA. Remember that all the stores have hidden cameras.

To drive in Spain, you must be 18 years of age and have an international driver's license in addition to your driver's license.

TRAVEL DOCUMENTS

To travel to Spain, a valid passport is required. The expiration date must exceed the travel date by at least three months. For example, if the return date is March 7, 2024, the passport must be valid until June 2024. A visa is not required for a stay of three months or less.

Since the Students are minors, a notarized written authorization for traveling and to be treated in case of an emergency (forms are at the end of this booklet) from the parents or legal guardians must be issued.

To prevent problems in case of passport loss, all students must have a copy of the passport. The coordinators will keep the original documents upon departure and give the students the copy.

POTENTIAL ISSUES OR PROBLEMS

Students are responsible to notify coordinators immediately shall any issues or problems arise. The coordinator will assess the situation and recommend the appropriate course of action.

PHONE CALLS

Spain is six hours ahead of the United States, for instance: 9:00 am in the USA is 3:00 pm In Spain. We recommend not using your cell phones to call since the international rates are very expensive.

The best option is to buy a phone card. Phone cards are readily available and can be used from any phone. The

day of arrival, the families will be contacted by the coordinator via email.

In case of an emergency, the coordinators will communicate by phone with the parents immediately.

INTERNET

Each student would need to ask the host family about the use or availability of internet.

HOST FAMILY

The objective of the program is to ensure students have an opportunity to practice and improve their Spanish as well as to learn about the Spanish culture. However, the success of the program will depend mainly on the positive attitude shown at home with your host family. Communication and integration with the family are very important. Students are expected to fully integrate with the family and consequently to collaborate with the domestic task such as: doing dishes, setting the table and cleaning the table up, keeping your room organized, etc.. Remember to always be polite and show good manners.

Although not a requirement, it is recommended to bring a gift to the family. It is suggested to bring something simple but representative of New Hampshire such as: books of New Hampshire, pictures, a magnet, a lighthouse, maple syrup, etc.

If you are going to go on a trip with the family, you will need to notify the coordinators and let them know where you will be.

MONEY

The currency in Spain is the Euro. Currently the conversion rate is approximately \$1.08 per Euro. It is recommended students bring €100 per week.

LUGGAGE

Airlines allow to check-in one suitcase of less than 50 lb per person. Excess weight will be fined by the airline at the student's expense. One carry-on bag not to exceed 20 lb of weight is allowed.

If you are planning to bring souvenirs from Spain, remember to leave extra room in your suitcase.

Voltage in Europe is 220 KW. If you are bringing electrical devices, make sure you have the adequate adaptor or you risk burning your electrical devices. You can check what you need at stores such as Radio Shack.

The non-fulfillment of any of these rules will cause a termination of the program, consequently, the student would have to return to the United States at the parent's additional expenses.
